3. Approval of last minutes: no discussion, Jay moved to approve—Danny Trenholm 2nd---Unanimous vote=Approved

4. Presidents Opening comments:

- a. This week (11-6-2025): we will begin filling of divots on course. Course will provide buckets and Jeff will ask all to completely fill the divot (sand includes seed) as many people do not do this properly.
- b. Guest Pat Woerner is present today and will be presented next meeting for approval to replace Dan Jalbert as Secretary in order to comply with By-Laws. . Recommending a new position on board, Sponsorship Chairman--to help connect with and solicit new sponsors. Tom Evans was mentioned as a candidate (Jeff has asked him and he is available to step in). Tom had a career in Sales. This will be a Volunteer position and not a voting position.
- c. Emphasis to all to get out for General Meeting on Dec. 4 for voting. There are 4 coupons from Prestige Golf for \$300. We will need a check in person to set up the raffle drawing. Emphasis—raffle entries must be golf cart owners. John M will not be at this meeting. Danny Trenholm can have 2 names of each person—keep 1 turn 1 in for raffle. Also we will only raffle 2 coupons at this time.
- d. We will have 3 of the 4 new Sponsor Tee signs this week. Charles Glovsky has volunteered to put them out on 1st & 10th tee boxes.
- e. Jim Steinmetz will assist Steve with food for events.
- f. Our **Christmas Party Dec. 6** – Jay will have 12 tables set up. There will be 2 drawings. Jim N. and PGA store have donated visors for raffle/drawing. Jay had question about No-shows. If valid reason (eg.medical) Jeff will give refunds. Jerry D said set up will start at 4:30. He had a DJ under contract but he has cancelled (we will not challenge contract as too costly—he has refunded money). Fortunately Jerry D found a replacement and set up contract (supposedly a better DJ).

5. Treasurer's report & Financials No report on this month at this time---instead we looked at Proposed Budget for next year that needs to be approved by membership at General Meeting Dec.4. Board members given copies.

Note changes: \$4,475 in website sponsorships now up to \$10,075 of which \$8,875 was in cash.

Key budget bills are for SNGA which bills on Oct.1 and then again on Feb 1st.

Special events splits note most of increase is due to food costs increasing. \$200/\$500.

Also note we added Brian to Pros payouts so extra \$200 there.

Jeff T has been collecting for vendors as of now... This was put to vote and approved.

6. Golf genius: Jerry Johnson reported he had questions about President's Cup this week as set up by Gary M. 2 Divisions with 5 Flights from Gold tees and 4 Flights from White tees. This caused issue for a couple players (i.e. Frank from Red tees, Snowden and another wanting Blended tees). These were resolved as Frank pulled out and Snowden is out. Was a problem with 3 no-shows again which messed up Flights. Brian Luigi for some reason was not flighted.

The uneven fights set up unequal payouts ---1 Flight only 10 players yet paid out to 6 places. Jerry will adjust these and send out new payout amounts.

6. (cont'd) Discussion about certain players who sign up and don't pay---should they or should they not be on list of winners?

In past they have and even though on list they just are not paid. Overall consensus is we will keep this the same for now.

7. Tournament chair & event recap: Steve K had not seen an invoice for food costs at Highland Falls for President's Cup. Due to this week's event being at Palm Valley, we won't have food/coffee available.

Jay is to receive and be responsible for Christmas party \$\$\$. Checks can be sent to his address preferable put in SC 18Holvers box.

Jerry J requested that webmaster post all results---Flight winners \$\$\$ and it is Net only for President's Cup.

Payouts for Flight winners ~\$300 available.

8. Handicap Report: John M reported only one issue/problem with a new member getting added to roster. John Graham apparently used his son's old email that hadn't been used for years. John contacted SNGA in Florida to delete old account. Hopefully now he can sign up for new account.
